TECHNICAL DATA SHEET- DRY RELEASE

DESCRIPTION AND USE

XCEL SURFACES DRY RELEASE contains a specially formulated releasing agent that forms a bond-breaking barrier between imprinting tools and the wet concrete which facilitates the release of flexible stamping tools or mats. It is a pigmented powder material that is applied directly to the wet surfaces to be imprinted. This product has been formulated to work in conjunction with stamping mats preventing suction that detracts from the finished product. During the stamping process, a portion of the DRY RELEASE becomes embedded, creating a variegated, antique look. The use of an Xcel clear sealer product is highly recommended to preserve the antique look. DRY RELEASE may also be used in conjunction with Xcel BUBBLE GUM RELEASE for accent coloring and antiquing effects.

APPLICATION

DRY APPLICATION METHOD: All surrounding areas should be protected from contamination by the dust created by the broadcast method of application. Plastic sheeting is recommended for masking. Timing is critical to successful application. If applied while the surface is too wet, more DRY RELEASE than necessary may become embedded in the surface and difficult to remove causing the final color to be mostly of that of the DRY RELEASE. If the DRY RELEASE is applied when the surface is to dry, very little DRY RELEASE will adhere to the surface causing a lack of correct finished color. Before application pour out half of the **DRY RELEASE** into a clean, dry container. Shake the container to aerate material and loosen any compaction before spreading on the surface. Apply evenly over the area using a casting motion. Use caution in windy conditions. The use of a dust mask is required to prevent inhalation. The coverage will vary depending on application. In general, 1 lb will cover 35 to 40 sq. ft. DRY RELEASE should not be used as the primary colorant for the surface.

WET APPLICATION METHOD: Mix approximately 1 oz. of **DRY RELEASE** per 28 oz. of **BUBBLE GUM RELEASE**; mix well. Continue periodic mixing to keep **DRY RELEASE** in suspension. Use a pump sprayer to apply a light coat of the **BUBBLE GUM RELEASE** / **DRY RELEASE** mix to both the surface to be stamped and the imprinting tool. Apply only to a small (10-15 sq. ft.) area that is ready to be stamped. IF applied to a large area it will evaporate before the surface can be textured. Never_trowel or mix the release into the surface to be stamped. Typical evaporation time is 1-2 hours.

FINISHING

DRY APPLICATION METHOD: Broom off excess release after surface has set and dried; this will remove excess **DRY RELEASE**. Take care not to wash off completely. Allow surface to dry thoroughly and seal with appropriate **XCEL** SEALER, depending on application (I.e., indoor, outdoor, etc.) Note: **DRY RELEASE** will wear away without protection; use of an **XCEL SEALER**, depending on application (i.e., indoor, outdoor, etc.).

WET APPLICATION METHOD: Lightly wash surface to be stained or sealed, being careful not to remove too much of the antiquing; let dry. Finish the surface with an appropriate **XCEL SEALER**, depending on application (i.e., indoor, outdoor, etc.).

PACKAGING

Xcel Surfaces **DRY RELEASE** is packaged in 1 and 5 pound boxes and available in 12 colors.
